Financial Reports

Director Myers presented the accounts payable and payroll for December, 2013.

Staff Reports

Commissioners briefly reviewed the Director of Finance and Personnel's Monthly Report. President Ludwig called in a few questions prior to the meeting.

Commissioners briefly reviewed the Superintendent of Parks' Monthly Report. Superintendent Sosnowski stated that man-made ice was available at Madison Meadow and Sunset Knoll. The Lagoon and Four Seasons have frozen ponds open for skating

Commissioners briefly reviewed the Deputy Director's Monthly Report. He reminded the Board that the Winter Carnival will be held February 8, 2014. He also added the Dance Show is February 22, 2014.

Commissioners briefly reviewed the Superintendent of Golf Operations' Monthly Report. Superintendent Ingram conveyed that 104 trees at Western Acres have been affected by Emerald Ash Borer and will need to come down.

Commissioners briefly reviewed the Executive Director's Monthly Report. The GFOA has been presented for the 14th year in Lombard. He mentioned that the district would like to arrange a tour of recreation facilities for Commissioners. Finally, he shared the Distinguished Agency Award and invited Commissioners and staff to autograph the reverse of the award.

Executive Director Friedrichs introduced a recent copy of the Pleasant Lane Tennis Courts and Hammerschmidt Playground Inter-Governmental Agreement. The attorney is still reviewing this document; staff is seeking approval of this IGA on first reading.

Commissioner Roberts made a motion to approve the School District #44 and Lombard Park District Shared Use of Grounds and Facilities IGA for the construction of the Pleasant Lane Tennis Courts and Hammerschmidt Playground in Return for use of School District #44 gym space upon first reading and upon attorney review as presented. Commissioner Scalzo seconded the motion. On a roll call vote; six ayes (Kuderna, Ludwig, Nolan, Richardt, Roberts, Scalzo). Motion carried.

Commissioner Kuderna made a motion to recommend a 3.0% salary increase for Executive Director Friedrichs. Commissioner Richardt seconded the motion. On a roll call vote ayes (Kuderna, Ludwig, Richardt), two nays (Nolan, Roberts), one abstain (Scalzo). Motion carried (3% increase).

There being no further business at 8:52 pm, Commissioner Kuderna made a motion to adjourn the Regular Board Meeting of January 28, 2014. Commissioner Richardt seconded the motion. On a call for the vote, six ayes: (Kuderna, Ludwig, Nolan, Richardt, Roberts, Scalzo). Motion carried.
